### DEPOSITS AND PAYMENTS

1) For most FE and HE courses (academic), a deposit of 50% of fees is required before an unconditional offer or CAS is issued (after meeting other conditions). The remaining 50% is due at enrolment. This is with the exception of the Access to Higher Education courses where the full fee is required before an unconditional offer or CAS is issued (after meeting other conditions). There may be further financial requirements to attain a study visa.
